Tim briefed that after surviving one of the worst ice storms in history for Shiawassee County we were hit with one of the worst snow storms in history. These two storms really took a toll on both the equipment and the personnel out here. An outstanding job was accomplished by many volunteers working at the airport during these storms. Rick Musson briefed that the team at the airport did an outstanding job and had the airport open before many subdivisions in the area had been touched.

All vehicles are up and running, except the Alles Chamers, which the transmission is still being rebuilt.

Tim briefed that the fuel sales so far since January 1st, 2014 are 334.1 gallons and for 2013 was 10,641.7.

Tim discussed the airport lighting problems since the ice storm. We have an electrician coming to the airport on Friday morning to work on the lighting.

The Civil Air Patrol has two gliders at the airport at present. The second glider came here from the Illinois Wing. It is here for some of the senior members in Michigan to work on completing their glider rating.
