# FINANCIAL REPORT:

Garry Csapos presented the financial report from the Shiawassee County Financial Administrator showing a cash Trial Balance of \$24,903.59 ending 10/31/2017 and unpaid bills of \$3,868.61. Motion to pay the bills as presented by Brent Wesley and supported by Chuck Kerridge. Roll Call: - Approved by all present.

# **MANAGERS REPORT:**

Garry Csapos reported that fuel sales so far for the month of November 2017 were 1196.48 gallons and total for the year are 36319.21 gallons. On Tuesday October 17, 2017 Pyramid Paving Co. completed paving Taxi Street 1. On Tuesday Aclara, a company hired by the City of Owosso upgraded the water meters at the Terminal Building, the Sascon Hangar and the Café. Also on Tuesday we closed the Huntington Bank account and deposited the \$749.82 into our account with the Shiaswassee County Treasurer Office. Juan Zapata of MDOT Aeronautics inspected the Airport on Thursday Novenber 2, 2017. The inspection went well and he commended the Airport Staff for a rapid response to correcting the problems. We will have our Generality Utility Licence reinstated soon. Doug Haskins the Airport Maintence Director and the Airport Manager are looking into possible issues that may occur with our ageing fuel system.

# **UNFINISHED BUSINESS:**

- a. David Joye of RS&H reported that last week he did a final Punch List for the Crack Seal & Paint project. There were over 90 deficiencies recorded on this project and all of these have to be addressed before the contract can be closed and the contractor be paid. He expects the contractor to return in the spring address the problems. In the meantime we will make progress payments. The first pay estimate and draft change order have been produced. We have MDOT support for withholding 25% until the problems are addressed. Motion to pay the first payment estimate of 75% with the caveat that the certified payrolls must have been received. - b. John Challender explained how we arrived at the choice of recommending the law firm of Ashley and Zaleski to represent the Airport. Motion to retain Curtis Zaleski as the Airport Attorney was made by John Challender and supported by Brent Wesley. Roll Call: -Approved by all present.
- c. Richard Updated the Board on the acquisition of the new Snow Removal Equipment (SRE). The tractor equipment is at D & G and can be seen by anyone who is interested. The paint job exceeded our expectations and all of the equipment is present and ready to be retrofitted. Rick has the completed purchase order and will sign it upon delivery. All American made we hope delivery to be in a week to 10 days.
