The parking lot land lease was mailed to Young Chevrolet Cadillac and payment was received on February 1, 2018. Our transportation problem of getting people from the Airport to places in the community may be solved. Shawn Parker said he will provide UBER service for passengers flying to the Airport. I would like to commend Doug Haskins and Rick Musson for their work clearing the snow from last Sunday's snow storm while most od the nation was watching the Super Bowl. There was some discussion about hunting policy for next year.

UNFINISHED BUSINESS:

- a. Rick Musson reported that the Agricultural land lease needs to updated so that if the Solar Company (NextSun Energy) chooses to execute their option it gives them the right to pay off the farmer for his loses.
- b. There is no movement on the Crack Seal contract with Axtell until spring.
- c. Rick received the Solar Panel Layout Sheets from David Joye of RS&H. The new drawings have elevation grades which indicate how high and how close the panels can be next to runways. This information has been submitted to MDOT for there review. There was some discussion about the solar company's desire to have this information with the lease option but that cannot happen until there is a plan first. The airport could receive as much as \$500 per acre of land used by the solar company for solar panels.
